Accepting Building Capacity for Local, State, and Tribal Child Death Review and Fetal-Infant Mortality Review Teams grant funding and amending the 2024 Rock County Public Health Department Budget

WHEREAS, the National Center for Fatality Review and Prevention is the administrator of the *Building Capacity for Local, State, and Tribal Child Death Review and Fetal-Infant Mortality Review Teams* Grant Program, which provides funding to local health departments; and,

WHEREAS, the funding will support efforts to develop Rock County’s Child Death Review Team; and,

WHEREAS, fatality review teams bring together partners such as first responders, social service agencies, healthcare systems, and public health to identify contributing factors to certain types of fatalities; and,

WHEREAS, fatality review teams then develop strategies to prevent future deaths; and,

WHEREAS, funding will specifically support the development of data sharing agreements, implement best practices for fatality review coordination, and support the continuation of Direct On Scene Education Training with first responders; and,

WHEREAS, the funding is for the time period of January 1, 2024-June 30, 2024.

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this 14th day of March, 2024 does hereby authorize Rock County Public Health Department to accept funding of \$29,052 through the National Center for Fatality Review and Prevention’s *Building Capacity for Local, State, and Tribal Child Death Review and Fetal-Infant Mortality Review* Grant and amend the 2024 Rock County Public Health Department budget as follows:
