1 **WHEREAS**, Jay Williams began his employment with Rock County on March 2, 1998 as a Deputy
2 Sheriff. He was promoted to Sergeant on April 18, 2011; and,

4 **WHEREAS**, Sergeant Williams has diligently served the citizens of Rock County as a dedicated and
5 valued employee of Rock County over the past 26 years, and having worked under five Sheriffs over the
6 course of his career: Howard Erickson, Eric Runaas, Robert Spoden, Troy Knudson and Curtis Fell; and,

8 **WHEREAS**, Sergeant Williams has been assigned to the Patrol Bureau, Court Services Bureau,
9 Diversion Program, Jail Division and the Community Corrections Program, to include supervising the
10 Rock County Education and Criminal Addictions Program (RECAP), the Jail Re-Entry and In-Custody
11 Treatment Program, Drug Court, OWI Treatment Court and Veterans Court Programs, Electronic
12 Monitoring Program, Huber Program, Workender Program, and Project Lifesaver Program; and,

14 **WHEREAS**, Sergeant Williams has received numerous letters of appreciation and commendations
15 including a Community Service Award in 2015 and the Retired Sheriffs Leadership Award in 2024. He
16 has served as a Firearms Instructor, Defense and Arrest Tactics (DAAT) Instructor, Boater Safety
17 Instructor, Boat Patrol Team member and Recreational Safety-Rescue Team member. He has also
18 served on the Leadership Committee for the Substance Misuse Task Force, the Risk Reduction
19 Subcommittee for the Evidence Based Decision Making (EBDM) Program, a board member for the
20 Wisconsin Association of Treatment Court Professionals (WATCP) and Janesville Mobilizing 4 Change
21 (JM4C), a member of the National Association of Drug Court Professionals; and;
