Recognizing Julie Fuelleman

1 **WHEREAS**, Julie Fuelleman has served the citizens of Rock County for over **11** years as a dedicated
2 and valued employee of Rock County; and,

4 **WHEREAS**, Ms. Fuelleman began her career on November 2011 with Rock County as a Youth
5 Services Diversion with the Human Services Department. In this role she provided skills building
6 interventions, mentoring, social skills, and community living skills to at risk and delinquent youth
7 throughout Rock County. In 2019, she moved into the Neighborhood Specialist position. This was a
8 new initiative to work directly with at risk families prior to entering the Human Services system.
9 Through collaboration with community partners, she increased natural supports and created safe spaces
10 for families to ask for and receive assistance. She started and expanded a natural support system for
11 single parents through Mom's groups in Janesville and Beloit. Her collaboration and relationship
12 building with community partners enabled her to create a position that has increased protective factors in
13 at-risk families in every part of the community. Whether it has been providing skills building groups
14 with youth from 10-17 or skills building activities for parents in the community, Julie has been diligent
15 in creating a welcoming environment for families; and,

17 **WHEREAS**, Ms. Fuelleman has decided to move on from Rock County after 11 years of dedicated
18 service on June 7, 2024; and,

20 **WHEREAS**, Ms. Fuelleman's work has exemplified the core values of respect and hope outlined in the
21 HSD mission statement. In her 11 years of service, she has consistently worked to assure that the
22 residents of Rock County received the best possible care and service. She is regarded by her coworkers
23 and community partners as a dedicated and compassionate presence that will be greatly missed by all
24 who have worked with her; and,
