AD HOC BROADBAND COMMITTEE
Minutes – August 10, 2021

Call to Order. Chair Bostwick called the meeting of the Ad Hoc Broadband Committee to order at 10:30 A.M. via telephone conference.

Committee Members Present via phone: Supervisors Mawhinney, Richard Bostwick, Homan, Sweeney, and Davis.

Committee Members Absent: None.

Staff Members Present via Phone: Randy Terronez, Assistant to County Administrator; Bridget Laurent, Deputy Corporation Counsel; Jim Sandvig, Director of IT; James Otterstein, Economic Development Manager; and Josh Smith, County Administrator.

Others Present: Supervisors Wilson and Beaver; Steve Schneider, Bug Tussel; Kim Gruebling, Town of Union; Tim Tollefson, Town of Harmony; and Russell Berg, Nokomis Networking.

Approval of Agenda. Supervisor Sweeney moved approval of the agenda as presented, second by Supervisor Mawhinney. ADOPTED.

Discussion of Next Steps

James Otterstein suggested given timing and priorities, the County should move forward without a broadband needs assessment. For example, a number of Rock County broadband applications have been submitted and several resident/stakeholder forums have been convened throughout the County during the recent years. As a result, ample documentation has already been compiled regarding broadband coverage and speeds. In consideration of the complexities and nuances of this data, though, the County will need to utilize a third-party to help identify and prioritize its American Rescue Plan Act (ARPA) broadband investments.

Randy went over the Next Steps sheet that was included in the agenda packet. The committee identified that the immediate next step is to let the municipalities know that Rock County has an Ad Hoc Broadband Committee and is working to improve broadband in Rock County.

Discussion and possible approval of resolution to contract with Nokomis Networking for consulting services
